Bio 1: Emerson Foy

Bio 2: Mary Alverez

Mary graduated in the top 3% of her senior class at University High School in 1985. After high school she went on to earn a BA from Long Beach State University in accounting. While at college, she met her husband Kurt, whom she married a few years later.

Mary and Kurt decided to start a family, having their first child, Emma in the summer of 1994. The couple decided to have three other children, each two years apart in age. Mary enjoyed the challenges of motherhood, and the opportunity to give her children more than she had growing up. With Kurt leading a successful career, Mary welcomed the opportunity to stay at home with their four children.

Life was good for the Alverez family until Kurt died in a tragic car accident. Mary was devastated and struggled to do daily activities. To make things worse, the family had not purchased life insurance. Mary realized she had to pull herself out of the depression and get a job to provide for her family and started to look for work as an accountant. Unfortunately, she found it difficult to find gainful employment because she had no formal work experience. Even with a degree in accounting, the economy was in a recession and the accounting firms were not hiring. With money tight, Peter grew up in a life of poverty.

Unable to send Peter to preschool, his parents enrolled him at the local elementary school. Peter struggled in school from the beginning. Since he only spoke Russian at home, he struggled with English only instruction and quickly fell behind.

Peter's parents found it difficult to make ends meet and as a result had to work multiple jobs, which kept them away from the house. Consequently, Peter had too much freedom and no one to guide him through the difficult decisions of life.

Peter is not afraid to put in an honest day's work. He worked odd jobs in high school just to help his parents put food on the table. Peter's fortunes turned quickly as he began hanging out with the wrong crowd instead of going to school. Like many young boys in the neighborhood, Peter got caught up in the local gang. As a 16 year old, Peter had several issues with the law and spent time in a juvenile facility. His life quickly spiraled out of control.
